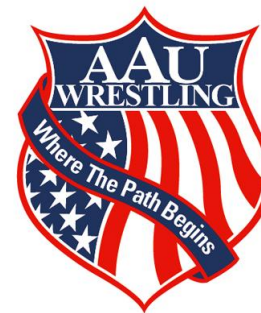

TEAM OHIO is a freestyle wrestling club that consists of over 60 of Ohio's best wrestlers. TEAM OHIO members train together in a four-day mini-camp (July 26-30) and then compete in the AAU Junior Olympic Games (July 31-August 4), which will be held in Detroit, MI this year. The tournament is a week-long, round-robin, freestyle dual tournament.

TEAM OHIO members get in over 15 freestyle matches against elite competition from all around the country.

--The AAU Junior Olympic Games will be held @ The Suburban Collection Showplace in Novi, Michigan from July 30th-August 4th. Get more info at <http://aauwrestling.net/> and [www.aaujrogames.org](http://www.aaujrogames.org)  
--TEAM OHIO will take 4 teams (14 wrestlers and 3 coaches per team) to Detroit, Michigan to compete.  
--There will be a 4-day mandatory mini-camp held at Delaware Hayes High School Wed. July 26-Sat. July 30th. . --Housing for this mini-camp will be made available to Team Ohio members.  
--Team Ohio will leave for Michigan on Saturday July 30th. Weigh-ins will be on this day.  
--We travel in a 56-passenger coach bus and two 15-passenger vans.  
--Check-in and registration is on Sat. July 30th at The Suburban Collection Showplace  
--Weigh ins will be immediately following registration. . NOTE: THERE IS ONLY ONE WEIGH IN FOR THE ENTIRE WEEK OF JUNIOR OLYMPIC GAMES!  
--Each wrestlers will get at least 10 matches...likely more than 15.  
--The competition is very good with teams from all over the United States.  
--COST: It is our goal to keep the total cost of the trip--which includes the mini camp, tournament entry fees, team gear, hotels, and all meals--under \$900.  
--To hold a qualifier champion's team spot, there will be a \$275 non-refundable deposit due 3 weeks after the qualifier.  
--Each team member will receive: the above mentioned transportation and accommodations; training and instruction; housing during the mini-camp; meals during the mini-camp; meals while in MI; tournament entry fee; 2 TEAM OHIO singlets (red and blue); TEAM OHIO tee-shirt, shorts, warm-up jacket, and bag.

What is a petition and how do I do it?

A petition is a written request to become a member of TEAM OHIO from wrestlers who did not win their weight at the qualifying tournament, who want to wrestle at another weight other than what they did at the qualifier, or who were unable to attend a qualifier. The petition review committee, which consists of Team Ohio coaches, reviews all petitions after the Delaware Hayes qualifier and adds individuals who didn't win the qualifier who make Team Ohio stronger. Anyone can petition to be on the team. A petition does not determine 1st-4th team status; that's done at the mini-camp. The right side of this page can be sent in as a petition. Petitions will be accepted in ONLY 2 ways: (1.) through mail BEFORE APRIL 27th or (2.) in person on the day of the Delaware Hayes Qualifier (April 30). If mailed, the petition must be accompanied by a \$20 REVIEW FEE (the cost of the qualifier entry fee). Turn petitions in to the tournament director after competition or mail them to

Wrestlers will be notified the week following the Delaware Hayes Qualifier on their status. Petitions will be evaluated on the following: Accomplishments (state, district, tourn., record); Past team member in good standing; Results in AAU Junior Olympic Team Qualifier; Team Ohio Coach recommendation.

This event is licensed by the Amateur Athletic Union of the U. S., Inc. All participants must have a current AAU membership. AAU membership may not be included as part of the entry fee to the event. AAU Youth Athlete membership must be obtained before the competition begins except where the event operator has a laptop available with an internet connection. Be Prepared: Adult and Non Athlete memberships are no longer instant and cannot be applied for at event. Please allow 10 days for membership to be processed.
