Olympic Sparring will begin at the completion of point sparring.

AAU Membership This is an AAU sanctioned tournament. AAU membership is **required** for all **competitors, coaches, officials** and **staff**. Cost of membership: Youth = \$14. Ages 5 to 20
You may go online and obtain your AAU membership or purchase it at the check in time at the event.
Be Prepared: Adult and Non Athlete memberships are no longer instant and cannot be applied for at the event. Please allow 10 days for membership to be processed

Athlete Fees:

Coach/Spectator fee **Spectator fee will be \$5.00 for all ages of 5 and Older.** **There is no fee for coaches,** however, to coach you must have taken the 2012 AAU Coach online clinic, adhere to proper attire and **pre-register** to coach this event.

Athlete Registration Deadline: **Registration deadline is October 14. There will be a \$15 late fee for registrations postmarked October 15-21. Absolutely no registrations will be accepted after October 21.**

Awards: AAU will be awarded for 1st, 2nd, and 3rd places for all events.

Rules: AAU tournament rules will apply with the following modifications. Trim and school patches will be allowed on uniforms, These are modifications allowed for local tournaments only. The current AAU rules can be viewed and downloaded from the AAU web site www.aautaekwondo.org.

Equipment: **Point sparring:** foam hands and feet, headgear, mouth guards, and groin cup (for all male competitors) are mandatory. Forearm, shin/instep, and rib guard are optional.
Olympic Sparring: White only shin/instep and forearm protectors, headgear, mouth guards, hogu and groin protection.

Board Breaking: All boards shall be purchased at the event for the price of \$2.00 per board. Competitor will have one (1) minute to setup their routine. You may setup as many station as you like. We will have people to hold boards, we suggest you bring your own board holders.

Forms: AAU recognizes forms from the World Taekwondo Federation, International Taekwondo Federation / Jhoon Rhee, Tang Soo Do / Moo Duk Kwan
Bracketed competition will be used. Two competitors will preform at the same time and judges will award one competitor as the winner. Same as in sparring

Sparring: All matches will consist of two (2) rounds of 90 seconds (1 ½ minutes) with a 30 second rest in between each round. Point gap will be 7 points after the 1st round

All coaches are required to complete the online coach's clinic and referees are required to attend an official's clinic prior to working this event. Officials and coaches clinic information can be found at the AAU website www.aautaekwondo.org.
